We are writing to you because of your support of human rights issues in the U.S. This fall, the Freedom Now Campaign for Human Rights and Amnesty for Political Prisoners in the U.S. will be sponsoring regional tribunals in order to publicize our on-going work around this issue and more importantly, to publicize and build support for the International Tribunal on Human Rights Violations of Political Prisoners and Prisoners of War in the U.S., to take place at Hunter College in New York City on December 7-10, 1990.

As part of the fund-raising effort, we are publishing a journal in salute to the tribunal and hope that you or your organization will purchase an ad in support of our efforts. The journal itself will have important messages from political prisoners and prisoners of war in the U.S. as well as autobiographical information, a report on the preparations for the Tribunal by its Coordinator, Dr. Luis Nieves Falcón, and the most up to date listing yet of the addresses of the political prisoners and pows in the U.S.


