THE TWO YEAR BATTLE OF RUCHELL MAGEE TO DEFEND HIMSELF SUFFERED
AN EXTREMELY SERIOUS SETBACK ON TUESDAY. ~~XXXXXXXXXX~~

AT THE LAST HEARING BOTH RUCHELL MAGEE AND HIS CO COUNSEL ROBERT
CARRAW MADE MOTIONS TO DISQUALIFY THE LATEST JUDGE APPOINTED IN
THE CASE, MORTON COLVIN OF SAN FRANCISCO. RUCHELL MAGEE'S ARGUMENTS
INCLUDED CHARGES OF PREJUDICE AGAINST COLVIN FOR SUSTAINING AND
CONINUING THE GAG RULE, WHICH PREVENTS ANY MEMBER OF THE PRESS
FROM INTERVIEWING RUCHELL. RUCHELL ARGUES THAT THIS IS NOT ONLY
UNCONSTITUTIONAL BUT HAS OPERATED IN A RACIST WAY, ESPECIALLY
BECAUSE PROSECUTION REPORTS OF HIS IQ AND CHARACTER ARE PRINTED
IN THE PAPERS WHILE HE HAS NO WAY TO ANSWER THESE REPORTS. AT THE
LAST HEARING THE PROSECUTION INTRODUCED MOTIONS QUESTIONING RUCHELL'S
SANITY AND HIS COMPETENCE TO DEFEND HIMSELF. RUCHELL ARGUED THAT
JUDGE COLVIN HAD NO RIGHT TO ALLOW THOSE MOTIONS TO BE CONSIDERED
YET SINCE HE WAS FACING A MOTION OF DISQUALIFICATION. CO COUNSEL
CARRAW ALSO MADE A MOTION FOR DISQUALIFICATION -- OUTLINING
NUMEROUS CONNECTIONS BETWEEN JUDGE COLVIN AND THE MARIN COUNTY
JUDICIARY AND POLITICAL SCENE, INCLUDING CLOSE FRIENDSHIP WITH
JUDGE HAROLD HALEY WHO WAS KILLED DURING THE EVENTS AT THE MARIN
COUNTY COURTHOUSE ON AUGUST 7th 1970.

~~ON TUESDAY~~, WITHOUT A PUBLIC HEARING, THE MOTION FOR THE
DISQUALIFICATION OF JUDGE COLVIN WAS DENIED. THE STATE
JUDICIAL COUNCIL HAD APPOINTED A SANTA CLARA JUDGE, BRUCE
ALLEN, TO RULE ON THE MOTION. JUDGE ALLEN ISSUED A BRIEF
ORDER DENYING RUCHELL'S REQUEST FOR DISQUALIFICATION WITHOUT
ANY COMMENT. APPARENTLY CO COUNSEL CARRAW WAS NOT EVEN
INFORMED THAT THIS WAS HAPPENING.

This was the first organized public support for Ruchell Magee coming

after a recess, Judge Colvin denied the motion and Carrow continued as co-counsel.

The rest of the proceedings dealt with the right of self-defense and sanity. Prosecutor Eric Collins argued that ^{on the basis of} mental tests, background, courtroom conduct, inability to get along with attorneys, ~~and~~ Ruchell was not competent to defend himself. Carrow ~~said~~ stated that there is no precedent for one ~~trial~~ judge to reverse another ^{on the matter} that Colvin could not reverse Judge Lindbergs orders.

In his ruling Judge Colvin said to allow Ruchell to defend himself ~~or participate~~ ^{directly or by counsel} would be contrary to the interests of justice. He called Ruchell's motion + statements confused and rambling, and ruled that Ruchell could only speak thru an attorney. He also appointed two psychiatrists to examine Ruchell.

And so almost 2 years after the events of Aug 27th at the Marin County Courthouse, Ruchell Magee has been denied the right to defend himself, ~~by~~ judge who it has been reported to be a close friend of the judge ^{who} ruled in Marin County is silly in the case.

Co counsel Carrow ^{then} asked to withdraw from the case, but ~~the~~ ^{the} hearing on the request will not happen until after pretrial which ^{now} ~~is~~ ^{is} scheduled for August 15th at 10 AM in San Francisco.

The hearing ^{with Judge Colvin}
~~Judge Colvin~~ began by warning the spectators that
no disturbances would be tolerated. Russell Magee
was brought in, smiled and gave a clenched fist
salute. The judge warned him to behave in a
proper manner, and that in the event of misconduct
he would be taken out.

W Immediately Russell seized the initiative, saying
he had filed notice to have the case taken out
of the state courts into the federal courts.
Since Judge Conti, one of the 7 previous judges
in the case, had prohibited him from filing any
motions with the Federal Ct for Northern California,
he said he had also filed it with the Court
in Los Angeles. ~~Having said that~~ He said Colvin
had no jurisdiction until the Federal Court
ruled on his motion and ~~as he~~ ^{as he} was continuing,
with the judge interrupting, just as the judge
was going to remove him he motioned for his
own removal and left, smiling and to
much applause, raised fists and shouts of
right on from the spectators.

Judge Colvin then said if there was one
more "outbreak" all spectators would be cleared
from the court and "offenders" brought before him
on contempt charges.

Then followed consideration of a motion
filed by Russell Magee to remove co-counsel Cannon
from the case. Russell demanded that the
discussion be in public but the judge ruled
that it had to take place in chambers.

the rap brown trial is scheduled to begin on vietnamese independence day...september 2nd....in new york city...

STEPHANIE IS BEING FRAMED

At 1:25 A.M., January 30, 1972, a bomb blew up in a car in the parking lot of an all night restaurant in Oakland. Tommy Davenport Jr., a black man, died in the explosion. At the time, Stephanie Kline was home at a party in San Francisco.

The police issued an all points bulletin. Stephanie was wanted for questioning as the registered owner of the car. Later that day, they raided her house. They had a search warrant for explosives, but they found none. They did find—and photograph—personal papers, political posters and literature; and they stole address books.

The next day, when Stephanie and her lawyer went in to explain her whereabouts at the time of the explosion, she was grilled for 1½ hours—primarily about her associations with black people. When she refused to answer these questions, they booked her. Her photograph was plastered throughout the media and was shown to eyewitnesses. Even so, only two "eyewitnesses" identified her in the lineup as being at the scene.

On this "evidence" Stephanie was charged with murder and possession of explosives and taken to the Alameda County Jail at Santa Rita. Bail was set at \$75,000.

Stephanie is innocent. There are many people who can testify that she was at the party that night. But the state continues to prosecute.

THE DEATH OF TOMMY DAVENPORT

Stephanie did not know Tommy Davenport. We know very little about his life or how he came to die in that car. Nevertheless we feel a great loss at the death of another black brother. We are outraged that the state has not only exploited his life, but they are attempting to exploit his death in order to divide the black and white communities.

THE PRESS: DISTORT, DIVERT, AND DIVIDE

Stephanie is being presented to the black community as the assassin of a black man. Her work and her beliefs make this slur hideously absurd. She shares her medical skills at the San Francisco Women's Health Collective and at El Centro de Salud, a community-worker controlled clinic, in the Mission district. She supports the right of Third World and all oppressed people to control their lives and their communities; and history has shown that to insure this right, it is necessary to actively resist reactionary violence with revolutionary force.

To the white community, Stephanie is portrayed as a "mad bomber". While this country spends more on the military than on anything else—develops bombs, approves bombs,

and every day drops bombs—a bomb at home induces hysteria. The state cannot afford to look vulnerable, so they must find and convict bombing suspects, even at the cost of jailing innocent people.

FIVE-TO-LIFE

After four months the state allowed the murder charge to be dropped on a legal technicality. The charge had already served its purpose of justifying high bail and smearing Stephanie as a murderess. Dropping the murder charge doesn't make things easier, since she still faces an indeterminate sentence of five years to life on possession of explosives.

RAILROADS HAPPEN EVERY DAY

Trumped up charges are nothing new to the judicial system—neither is excessive bail. Every day great numbers of innocent poor and Third World people are brought up before the courts. Ninety per cent of all criminal defendants in the U.S. today plead guilty without a trial because they cannot afford a competent lawyer; they end up spending years in jail. We hope to raise the \$20,000 necessary for Stephanie's defense from small donations and fundraising efforts. This doesn't include all the work that just this one case is absorbing, while thousands go undefended.

EVERY PRISONER NEEDS POLITICAL SUPPORT

If Stephanie is acquitted, it is not going to be just because of her lawyers, but because of the visible support of the people. (The evidence against Hugo Pinell was no stronger than the evidence against the Soledad Brothers, but his support was weaker. He was found guilty. The Soledad Brothers were acquitted.) The struggle in the prisons and the movement to support political prisoners has shown our strength lies in racial and political unity.
