JUAN BOSCH, THE LEADER OF THE ~~LEFTIST~~ DOMINICAN REVOLUTIONARY PARTY, WAS ELECTED PRESIDENT OF THE DOMINICAN REPUBLIC IN 1962 AFTER THE ASSASSINATION OF RAFAEL TRUJILLO, A RIGHT WING DICTATOR. BOSCH'S GOVERNMENT WAS OVERTHROWN BY A MILITARY COUP IN 1963. ~~BUSINESS~~...The U.S. government has acknowledged that there are at least 10 separate agencies within the federal bureaucracy which conduct electronic surveillance and wire-tapping of American citizens. In numerous court cases, the Justice Department has admitted that the F.B.I., the I.R.S., the Bureau of Customs, the Bureau of Narcotics and Dangerous Drugs, and the Bureau of Alcohol, Tobacco and Firearms have all conducted wiretapping. In a recent New York case, John Davitt, the acting deputy assistant attorney general of the Justice Department's Internal Security Division, acknowledged in court that the U.S. Secret Service and the U.S. Postal Service also engage in wire-tapping. Added to the above seven agencies are three others admitted to in the course of the Pentagon papers trial. When attorneys for Daniel Ellsberg and Tony Russo, asked about federal wire-tapping, the government told the court that it had checked with the Defense Department, the Department of State, and the C.I.A. to determine whether any of those agencies had tapped phone lines.
