THE JURY HAS BEEN OUT IN THE RUCHELL MAGES TRIAL FOR MOST OF THE WEEK, REPORTING ITSELF UNABLE TO REACH AGREEMENT ON A VERDICT, *But*

JUDGE NORTON COLVIN HAS CONTINUED TO INSIST THAT THEY KEEP TRYING.

AS OF THIS MOMENT NO VERDICT HAS BEEN REACHED. *deliberations have ended today + will start again Sunday morning*

IMPORTANT EVIDENCE THAT THE JURY HAD ASKED TO SEE WAS THROWN INTO THE GARBAGE AND DEPUTIES HAD TO PICK THROUGH GARBAGE BINS IN THE BASEMENT TO FIND IT. THEY SAID THEY FOUND IT ALL, AND A MOTION FOR A MISTRIAL ON THESE GROUNDS WAS DENIED. IT SEEMS THE SAME THING

HAPPENED TO EVIDENCE IN ANOTHER MURDER CASE BEING TRIED IN SAN FRANCISCO...MAKES ONE WONDER...HAD TO SAY THAT THE MANY DAYS OF DELIBERATION MEANS...COULD B...

~~...FEDERAL WILLIAM CRAIG WALLACE BAKER, AND [unclear] THOMAS,
ALSO KNOWN AS THE HARLEM FOUR~~

THE HARLEM FOUR ARE FOUR BLACK MEN WHO WERE FIRST CHARGED WITH MURDER IN 1964. THEY WERE ACCUSED OF KILLING A WOMAN IN HER CLOTHING STORE IN HARLEM DURING A ROBBERY. THE CHARGES WERE MADE DURING THE SAME TIME THAT NEW YORK CITY NEWSPAPERS WERE FILLED WITH HEADLINES ABOUT AN ALLEGED BLACK YOUTH GROUP DEDICATED TO KILLING WHITES ~~XXXXXXXXXX~~ WHICH THE PAPERS NAMED "THE BLOOD BROTHERS." SEVERAL OF THE MEN CHARGED, WHO AT THE TIME WERE 17 AND 18 YEARS OLD, WERE KNOWN IN THE COMMUNITY AS SOCIAL ACTIVISTS. THEY ALL DENIED ANY CONNECTION WITH THE CRIME. ONE WITNESS WHO HAD PREVIOUSLY BEEN ARRESTED BY POLICE HAD NAMED THEM AND TESTIFIED THAT HE WITNESSED THE MURDER. THROUGH THE YEARS THIS WITNESS HAS SEVERAL TIMES SWITCHED HIS STORY, ONCE SAYING THAT POLICE FORCED HIM TO TELL THE STORY, THEN DENYING THAT THEY DID. SINCE 1964 THE FOUR MEN HAVE BEEN TRIED THREE TIMES. ~~XXXXXXXXXXXXXXXXXXXX~~ CONVICTION WAS ~~INVALIDATED~~ ^{INVALIDATED} AND TWO OTHER TRIALS ENDED IN HUNG JURIES. IN MARCH 1972 THEY WERE ~~RELEASED~~ ^{released} ON ~~BAIL~~ ^{RELEAS} AFTER BEING IN PRISON FOR EIGHT YEARS DURING THE PROCEEDINGS. THE STATE HAS SAID IT WOULD TRY THEM A FOURTH TIME, BUT TODAY, IN NEW YORK STATE SUPREME COURT THEY PLED GUILTY TO FIRST DEGREE MANSLAUGHTER AND WERE TOLD THEY WOULD BE FREED, SEEING AS THEY HAD ALREADY SERVED EIGHT YEARS. THE PLEA WAS MADE ~~AS PART OF~~ ^{as part of} AN AGREEMENT WITH THE DISTRICT ATTORNEY. THE JUDGE TODAY SAID, "I AM SUSPENDING SENTENCES. I HOPE YOU WILL MAKE SOMETHING OF YOUR LIVES. YOU'RE OLDER NOW -I HOPE WISER." AFTER THE HEARING ONE OF THE FOUR, WILLIAM CRAIG, SAID "WE'RE VERY EMOTIONAL. WHAT I'D LIKE TO SAY AND WHAT WE'D ALL LIKE TO SAY IS WE FEEL THE WORLD SHOULD KNOW WE'RE NOT GUILTY." DEFENSE ATTORNEY WILLIAM KUNSTLER ADDED, "IT IS A MARK OF A TRULY SICK SOCIETY WHEN FOUR YOUNG BLACK MEN FIND IT NECESSARY TO PLEAD GUILTY TO CRIMES THEY DID NOT COMMITT."

THE TAPES WERE INTRODUCED IN COURT. IN HIS TESTIMONY IN HIS OWN BEHALF, EARL GIBSON SAID THAT HERMAN JOHNSON HAD HAD AN IRRATIONAL HATRED OF HIM EVER SINCE HE HAD DENIED GIBSON DENIED JOHNSON ENTRANCE TO THE SAN QUENTIN BOXING PROGRAM.
