THERE WAS AN EXTRAORDINARY STORY BURIED IN THE NEWSPAPERS THIS WEEK.

IT TOOK PLACE AT WALPOLE STATE PRISON IN MASSACHUSETTS.

THERES BEEN A SERIES OF PROTESTS AND REBELLIONS THERE IN THE PAST FEW YEARS.

THIS WEEK GUARDS ACCIDENTALLY DISCOVERED THE ENTRANCE TO A MASS ESCAPE TUNNEL. THE TUNNEL BEGAN UNDERNEATH THE STAGE IN THE PRISON AUDITORIUM. IT WAS 400 FEET LONG. 200 MORE FEET AND IT WOULD HAVE PASSED BENEATH THE MAIN WALL OF THE PRISON AND MADE IT OUT TO A MA IN HIGHWAY.

PRISON AUTHORITIES SAID PRISONERS WORKED SECRETLY IN 24 HOUR SHIFTS OVER A PERIOD OF SEVERAL MONTHS. AUTHORITIES SAID THE TUNNEL ESCAPE COULD HAVE EMPTIED HALF OF THE 600 PRISONERS AT WALPOLE.

THE TUNNEL WAS DISCOVERED, AND ITS OBVIOUS THAT THERE WILL BE SERIOUS CONSEQUENCES FOR THOSE PRISONERS ^{WHO} ~~WHICH~~ PRISON AUTHORITIES BELIEVE TO BE LEADERS.

BUT EVEN THOUGH THE TUNNEL WAS DISCOVERED THE STORY HAS A DEEP SIGNIFICANCE. IMAGINE WHAT IT MEANS ABOUT PRISONER ORGANIZATION AND UNITY TO BE ABLE TO ~~SECRETLY~~ ^{SECRETLY,} WORK ^A PROBABLY WITH SPOONS AND WHATEVER ELSE THEY COULD FIND...TO WORK SECRETLY OVER A PERIOD OF MONTHS IN A MAXIMUM SECURITY PRISON, WITH CELL SHAKEDOWNS, ^{AND} PROTESTS GOING ON.

RETRIAL PRETRIAL HEARINGS FOR RUCHELL MAGEE WERE HELD IN SAN JOSE THIS WEEK. THE TRIAL WAS MOVED THERE FOLLOWING MAGEES MOTION FOR A CHANGE OF VENUE. AT THE HEARINGS RUCHELL MAGEE ARGUED FOR AN HOUR IN SUPPORT OF HIS CONSTITUTIONAL RIGHT TO DEFEND HIMSELF. THE JUDGE THEN CONDUCTED A COMPETENCY HEARING, IN A CLOSED SESSION, AND SAID HE WOULD RULE ON SELF DEFENSE NEXT WEEK. MAGEES COURT APPOINTED ATTORNEY, ROBERT CARROW, AGAIN SUBMITTED MOTION TO WITHDRAW FROM THE CASE, AND SAID THAT ~~EXXEX~~ THE COMPETENCY HEARING WAS UNNECESSARY BECAUSE AS MAGEE SAYS, REGARDLESS OF WHAT THE STATE SUPREME COURT SAYS, THERE IS A CONSTITUTIONAL RIGHT TO SELF DEFENSE. THE NEXT HEARING IS SCHEDULED FOR 10 AM NEXT TUESDAY JUNE 12th IN SAN JOSE.

A PRETRIAL HEARING FOR THE SAN QUENTIN SIX, BLACK AND LATIN PRISONERS CHARGED IN CONNECTION WITH THE EVENTS SURROUNDING THE KILLING OF GEORGE JACKSON, WILL ALSO BE HELD NEXT WEEK. THE SIX ^{in divisions} HAVE BEEN DEMANDING ATTORNEYS OF THEIR CHOICE, HAVE BEEN REMOVED FROM THE MAXIMUM SECURITY COURTROOM, AND ONE OF THEM, DAVID JOHNSON WAS BEATEN AND HAD HIS GLASSES BROKEN WHILE IN A HOLDING CELL ADJOINING THE COURTROOM. THE HEARINGS WERE WELL ATTENDED LAST WEEK. THE NEXT HEARING IS THIS COMING FRIDAY AT THE MARIN COUNTY CIVIC CENTER.

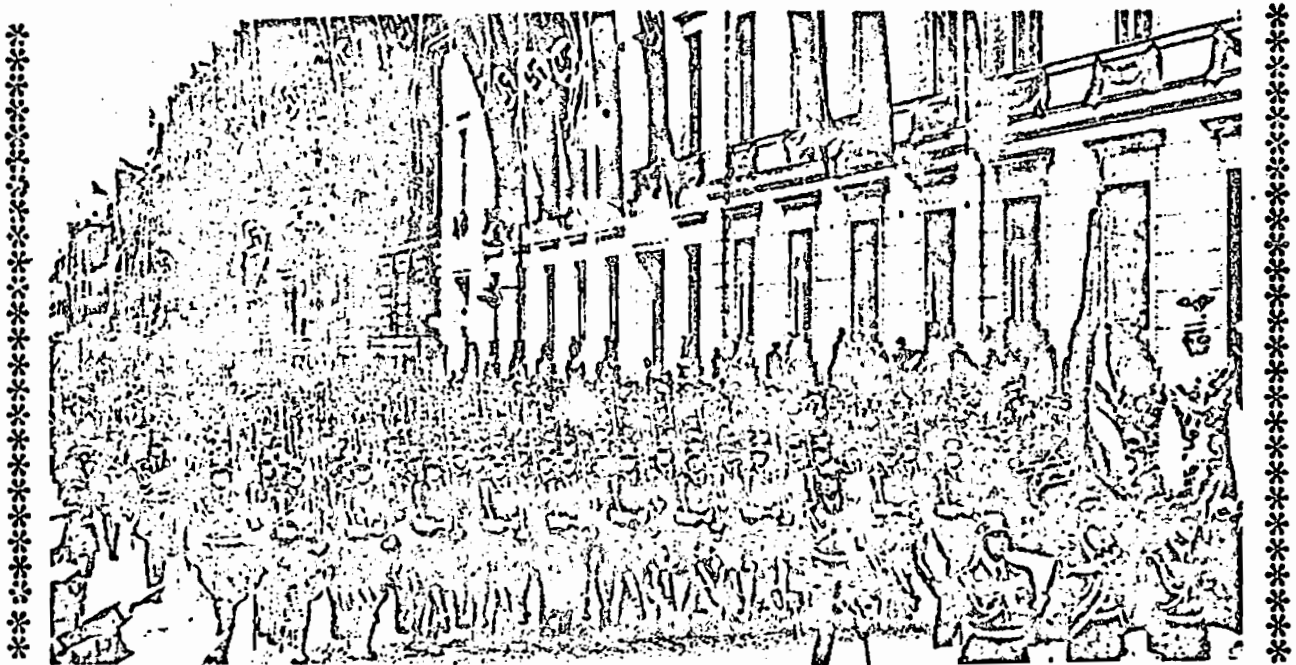
